GLOSSARY

Named Business Unit is defined as a unique Business Unit configured in Oracle Fusion Applications – a unit of an enterprise that performs one or many business functions that can be rolled up in a management hierarchy. A business unit can process transactions on behalf of many legal entities.

Named POD is defined as a unique Oracle Fusion Applications environment. A POD is the Production Environment running the Oracle Fusion Applications and any applicable non-Production Environments.

Named User is defined as an individual authorized by you to access the hosted service, regardless of whether the individual is actively accessing the hosted service at any given time. Hosted Named Users may include Business Network Administrators, Endorsing Trading Partners and Participating Trading Partners.

Operating Unit is defined as a unique Oracle E-Business Suite as an organization that:

- a. Stores subledger data separately from the data associated with other OUs that support a particular ledger (“Partitions”).
- b. Administers subledger rules such as those associated with transaction types, sequencing schemes, and other sales tax or VAT regulations (“Complies”).
- c. Administers user access to the data for processing and reporting (“Secures”).
- d. Is not product specific and automatically links all subledger products that post to a specific ledger.
- e. Applies to subledger business transaction and document data and associated data such as customer details. Subledger accounting data is not tagged with OU identification unless you elect to do so. General ledger data is not managed through OUs.

Administrator is defined as a Named User you authorize to access, use and configure the security and access functions of the system.

Employee is defined as (i) all of your full-time, part-time, temporary employees, and (ii) all of your agents, contractors and consultants where such agents, contractors and consultants have access to, use of, or are tracked by, the programs. The quantity of the licenses required is determined by the number of Hosted Employees and not the actual number of users. In addition, if you elect to outsource any business function(s) to another company, the following must be counted for purposes of determining the number of Hosted Employees: all of that other company’s full-time employees, part-time employees, temporary employees, agents, contractors and consultants that (i) are providing the outsourcing services and (ii) have access to, use of, or are tracked by, the programs.
